## PROVIDENCE STATEMENT OF FAITH

This corporation (Providence School) is based on the truths revealed in the written Word of God. We interpret these truths to have the following implications for our educational program:

### Statement on Scriptural Authority

WE BELIEVE that the Bible (both Old Testament and New Testament) is the Word of God, divinely inspired as originally given, and is the supreme authority in all matters (Exodus 24:4; Joshua 1:8; Psalm 1:2; Matthew 7:24; 2 Timothy 3:15-17).

### Statement on the Nature of God and Humankind

WE BELIEVE in one God, eternally existing in three persons: Father, Son, and Holy Spirit. Humankind is created in His image, creation and providence are revelatory of Him (Genesis 1:26; John 1:1; John 10:33; Philippians 2:9-11). Though created in His image, we believe in the fall and consequent total moral depravity of humanity, resulting in our exceeding sinfulness and lost estate, and necessitating our regeneration by the Holy Spirit (Psalm 143:2; Isaiah 53:6; Romans 3:23; 5:7-8; 5:12,19; 1 John 1:8, 10).

### Statement on Jesus Christ

WE BELIEVE that Jesus Christ is God manifested in the flesh, born of a virgin. He lived a sinless life, suffered and died on our behalf, arose bodily from the grave, ascended, and is coming again in power and glory (John 1:1, 14; John 10:30-33; Colossians 1:15, 2:9).

### Statement on the Holy Spirit

WE BELIEVE that God the Holy Spirit convicts us of sin, brings us to faith in Jesus Christ, and conforms us to the image of Christ. God the Holy Spirit regenerates and empowers his people to continue God's work, and for a life of holiness and service (Ezekiel 36:26-27; John 3:6-8; Romans 8:2-6; Titus 3:5-6).

### Statement on Christian Unity

WE BELIEVE in the spiritual unity of believers in our Lord Jesus Christ (Psalm 133:1; 1 Corinthians 1:10; Ephesians 4:11-13; Colossians 3:13-14).

## PROVIDENCE BEHAVIORAL EXPECTATIONS

The Providence community chooses, freely and willingly, to impose upon itself rules for behavior that serve both the long-range interests of the institution and the immediate good of its individual members. While we do not necessarily view these expectations as an index to maturity in Christ, we do regard violations as a serious breach of integrity within the community because each member has voluntarily chosen to associate with it and to accept its standards.

Providence School establishes the following specific behavioral expectations for all faculty and staff members:

- We will not condone or participate in practices that Scripture forbids. Such activities include occult practices, sexual relations outside of heterosexual marriage, drunkenness, theft, profanity, and dishonesty. We also recognize that Scripture condemns “sins of the spirit” such as covetousness, jealousy, pride, and lust. By their very nature, these sins are more difficult to discern. However, because they lie at the heart of the relationship between the individual and God they are of central concern to the Providence community.
- We uphold integrity as a core value of the community. Faculty and staff members are expected to take responsibility for their own violations of all behavioral guidelines and demonstrate commitment to the value of integrity in word and deed.
- We believe that the use of tobacco products and alcoholic beverages presents a danger to personal health. Under no circumstances shall any member of the community use or possess these products on campus or when attending school-related student activities.
- We uphold the laws of the local community, the nation, and the state of California. Such laws include prohibitions against possession or use of illegal drugs or drug paraphernalia, the purchase of alcohol for minors, the consumption of alcoholic beverages by persons under the age of 21, drunkenness, and driving under the influence of alcohol.
- Providence is committed to providing a learning and work environment free of harassment of any kind. Harassment of any type will not be tolerated.
- We expect our faculty and staff members who choose to marry to abide by the commitment to lifelong heterosexual marriage, and, whether single or married, to strive to maintain healthy family relationships.
- We consider the unborn fetus to be a human being and expect all faculty and staff members to support the sanctity of human life at least within the classroom and larger Providence community.
- We will join in the greater Christian community of Santa Barbara, regularly participating in a local church body.
